Gennaro Zezza is a leading researcher in the Stock-Flow-Consistent (SFC) modeling approach pioneered by Wynne Godley, with whom he worked from 1988. He is working on empirical SFC models for the U.S. and Europe, and on theoretical models for open economies.

Current research projects

1. U.S. growth in the medium term, and its relation with global imbalances. With D.B. Papadimitriou and M. Nikiforos. As part of the Levy Institute Macroeconomic Team, we periodically evaluate the prospects of the U.S. economy, conditional on monetary and fiscal policies, through a model we estimated and revised over the years.
2. Medium term prospects for Greece and the Eurozone. With D.B. Papadimitriou and M. Nikiforos. We periodically evaluate the prospects for the Greek economy, with the help of a model we estimated and updated over the years. In addition, we explore the impact of monetary reforms for other countries in the Eurozone
3. International monetary economics. With S. Valdecantos and J. Mazier. In this project we use theoretical stock-flow-consistent models to explore possible scenarios for reforms of the international monetary system, or of the Eurozone, in the light of Keynes’ proposal for an

International Clearing Union.

4. Micro and Macro Vulnerability. With A. Altissimi and F. Spinelli. We examine operational definitions of vulnerability both at the micro level – using monthly surveys of Italian households – and at the macro level – using growth regressions for a cross-section of countries, to investigate the usefulness of the concept with respect to other measures of poverty and well-being
